



HRD CORP PROPOSED POLICY ENHANCEMENTS TRAINING PROVIDER CIRCULARS 2, 3 & 4/2022

OVERVIEW

The following policy enhancements to be implemented:

1. 1 Director, 1 registered Training Provider

- An individual will be allowed to be a Director for ONLY ONE (1) registered Training Provider.

2. Enhancements to Government funding criteria

- Only Training Providers who have been registered with HRD Corp for more than 6 months will be eligible to participate in Government funded programmes.

3. Allowable Cost Matrix for Government funding

- Government funded programmes course fees will follow the HRD Corp Allowable Cost Matrix

4. No sub-contracting for Government funding

- TPs who are awarded government funded programmes WILL NOT be allowed to sub-contract the training to other parties.

5. Direct Engagement with Trainers

- HRD Corp to enable direct engagement of Trainers for HRD Corp programmes.

ENHANCEMENTS TO THE TERMS AND CONDITIONS FOR TRAINING PROVIDER REGISTRATION

<i>Implementation date</i>	<ul style="list-style-type: none">• 1 April 2022
<i>New TP registration</i>	<ul style="list-style-type: none">• Any new application with redundant director will be queried/rejected.
<i>TP renewal</i>	<ul style="list-style-type: none">• Any new application with redundant director will be queried.
<i>Government funded</i>	<ul style="list-style-type: none">• Only 1 approval per initiative at any one time
<i>Levy based</i>	<ul style="list-style-type: none">• No restriction as of now• HOWEVER, registered TPs are STRONGLY advised to look into this issue.• HRD Corp will announce any further developments by end July 2022.
<i>Other info</i>	<ul style="list-style-type: none">• HRD Corp will send registered letters to all 499 affected TPs by 1 April 2022.

ENHANCEMENTS TO THE TERMS AND CONDITIONS FOR HRD CORP GOVERNMENT FUNDED INITIATIVES

<i>Implementation date</i>	<ul style="list-style-type: none">• 1 April 2022
<i>Cooling off period</i>	<ul style="list-style-type: none">• Only TPs who have been registered for more than 6 months with HRD Corp will be able to participate in HRD Corp government funded initiatives.• This only applies for TP registration received starting 1 April 2022.
<i>Allowable Cost Matrix</i>	<ul style="list-style-type: none">• Course fees for government funded programs to follow the HRD Corp Allowable Cost Matrix
<i>No sub-contracting</i>	<ul style="list-style-type: none">• Sub-contracting is strictly prohibited for any courses approved under HRD Corp government funded initiatives.

DIRECT ENGAGEMENT OF HRD CORP ACCREDITED TRAINERS

<i>Implementation date</i>	<ul style="list-style-type: none">• 1 April 2022
<i>Direct engagement</i>	<ul style="list-style-type: none">• HRD Corp reserve the right to directly engage trainers to conduct courses for HRD Corp
<i>Accredited Trainers</i>	<ul style="list-style-type: none">• HRD Corp will only engage Accredited Trainers.
<i>Type of courses</i>	<ul style="list-style-type: none">• Collaboration courses;• HRD Corp signature courses; and• Any other courses where the trainer is selected and engaged directly by HRD Corp
